# NARS

On March 23, Senators Thomas Eagleton (D-MO) and Charles Mathias (R-MD) introduced S.905, the National Archives and Records Administration Act, to establish the independence of the National Archives and Records Service (NARS) from the General Services Administration (GSA). Among the senators who signed on as co-sponsor on the day of the bill's introduction was Tennessee's Democratic Senator, Jim Sasser. In a recent letter to the Tennessee Archivists, Senator Sasser expressed his belief that the National Archives' responsibility of preserving the nation's documentary heritage can best be achieved independently from GSA.

GSA, Senator Sasser said, has relegated NARS to a "low-priority status" which is reflected in its "inadequate funding for basic archival functions;" the reluctance of GSA to comprehend and appreciate "the less tangible archival and cultural activities of NARS;" and the demonstrated "danger in placing archival decisions in the hands of political appointees who can override expert professional judgements."

Sasser, who believes that "no price tag can be placed on the intrinsic value of the preservation of our nation's historical records," is cosponsoring S.905 to strengthen "the Archives for the future."

### SPRING MEETING

Tennessee Archivists Apring Meeting Red Boiling Springs, Tennessee May 19-20, 1983

The Tennessee Archivists Spring Meeting was held at the Donoho Hotel, Red Boiling Springs, TN, on May 19-20, 1983. President William J. MacArthur, Jr. (McClung Historical Collection, Knoxville) welcomed the group.

Vice-president John Thweatt (TSL&A) introduced Richard Belding (KY State Archives) who spoke on "Assessing the Needs Assessment Project: The Kentucky Experience." Belding mentioned that Tennessee is being considered for an assessment project.

The afternoon session continued with "Frugal Fixin's: Conservation on a Shoestring Budget," presented by Patricia Morris (TSL&A) and Marice Wolfe (Vanderbilt Special Collections).

Jean Waggener (TSL&A) relayed regrets from Tennessee State Librarian Olivia Young, who could not be present at the meeting.

Following dinner at the Donoho Hotel, Dr. Calvin Dickinson (Tenn. Technological University) addressed the group. After supplying a brief history of Red Boiling Springs' past as a resort area, Dickinson spoke about Memphis State University's Tennessee County series publishing project. The project, which was started in 1978, is now under the management of a new editor and is operating under new policies. Much of the writing is being done through professors at Tennessee's universities and Dr. Dickinson is currently working on the history of Morgan County for the series.

The group adjourned, retreating to the porch for rocking chairs and conversation.

On Friday, May 20, the Tennessee Archivists reconvened and heard Mrs. Shirley Hoskins speak about her research on the Cherokee Indians which led to the publication of CWY YE Cherokee Blood.

The business meeting was called to order by William MacArthur. The reading of the minutes was dispensed with since they were published in the Summer 1982 newsletter.

Treasurer David McWhirter (Disciples of Christ, Nashville) reported a balance of \$577.53 as of January 1, 1983. The balance does not reflect the finances of the May 19-20 meeting.

The matter of the unprocessed checks from the 1979 Nashville workshop registrations was brought up, with McWhirter requesting those who had attended the workshop to reissue checks to him to cover the \$25.00 registration fee.

Membership dues may be paid at any time. Full membership is \$5.00; \$3.00 for associate status.

President MacArthur reported that he has written twice to the Governor's office regarding the appointment of an archivist to the Tennessee State Library and Archives Advisory Board. There was no response to either letter and it appears that an Advisory Board has never been appointed.

Sally Ripatti (McClung Historical Collection, Knosville) reported that the Society of American Archivists is sponsoring a photograph workshop in Atlanta on June 15-17, 1983. The meetings will be held at the Georgia Department of Archives and History.

William MacArthur presented the following slate of officers for 1983-85. There were no nominations from the floor and the slate was unanimously elected. The 1983-85 officers are:

There was a brief discussion about the Fall meeting to be held in West Tennessee. A committee will be appointed to make the arrangements.

John Thweatt thanked William MacArthur for serving as president from 1981-83, and thanks were returned to John Thweatt for his work in organizing the meeting at Red Boiling Springs.

The meeting was adjourned.

#### **OFFICERS**

During the Spring meeting, the Tennessee Archivists elected their officers for the 1983-85 term. Although their names and faces are familiar to most of us, they may not be as well-known to the members who cannot regularly attend our meetings. In keeping with TA's committment to upgrading the archival profession within Tennessee through the exchange of information and ideas, the officers' biographical sketches are presented to the membership.

#### President

A native Memphian now residing in Clarks-ville, John H. Thweatt is Senior Archivist in the Archives and Manuscripts Section of the Tennessee State Library and Archives. Prior to coming to the State Library and Archives in 1971, he held teaching positions in the History Department of Austin Peay State University in Clarksville; Hargrave Academy in Chatham, Virginia; Texas A & I College; and in the Todd County, Kentucky, Public School System.

TA's president holds B.A. and M.A. degrees in History from Baylor University, and spent one year in the American Studies Program at the University of Denver in Denver, Colorado. He is also active in the Society of American Archivists, the Southern Historical Association, the Tennessee Historical Society, and the Association of Records Managers and Administrators.

# Vice - President

A records officer in the Records Administration Section of the Tennessee Valley Authority since September, 1980, Mark R. Winter holds a B.S. degree in History from Mankato State University in Mankato, Minnesota; and a M.A. in History, specializing in Archives and Records Management, from Colorado State University, Fort Collins, Colorado.

Prior to assuming his present position, Mark was the archivist for the Aurora Public School District in Aurora, Colorado. He has also been an oral history interviewer for local oral history projects, a historian for the U.S. Army, and currently is a resource person for a local history museum. A member of the Tennessee Archivists since 1980, Mark is also a member of the Society of American Archivists, the Oral History Association, the American Association for State and Local History, the National Council on Public History, and the Brown County (Minnesota) Historical Society.

#### Treasurer

David I. McWhirter is the Director of the Library and Archives for the Disciples of Christ Historical Society. He joined the staff of the Historical Society in October, 1976. Mr. McWhirter is responsible for supervising professional staff and the work of the library and archives comprising one of the significant research centers in American Protestantism. The Society extends its services to the Christian Church (Disciples of Christ), the Christian Churches, and the Churches of Christ.

Prior to coming to the Society, Mr.
McWhirter served on the library staff of the
Christian Theological Seminary starting in
1962. He holds a B.S.L.S. from the State
University of New York at Geneseo; a M.S.L.S.
from Syracuse University; and a B.D. from the
College of the Bible (now Lexinton Theological Seminary) in Lexinton, KY.

In addition to his duties as the Tennessee Archivists' treasurer, Mr. McWhirter is active in the American Theological Library Association, the Society of American Archivists, the Tennessee Theological Library Association, and the Belmont Hillsboro Neighbors, Inc.

Sally Ripatti was born in Ann Arbor, Michigan, and moved to Sevierville, Tennessee, at the age of thirteen. She received her B.A. in History from Birmingham-Southern College in Alabama in 1975 and her M.S. in Library and Information Science from the University of Tennessee at Knoxville in 1976. #### **EXHIBITS**

The Tennessee Valley Authority, as part of its 50th anniversary celebration, has two historic document exhibits available for loan to interested institutions and archives within the TVA service area.

The Historic Traveling Exhibit, "Independence Through Job Skills-A TVA Philosophy," traces the development of the job skills training program and the general adult education program which TVA began in 1933 in conjunction with its first construction project, Norris Dam. The exhibit features early photographs, maps, documents and original sketches.

The Unique TVA Documents Exhibit contains original documents, photographs, and artifacts. Included in the exhibit are a copy of the TVA Act signed by President Franklin D. Roosevelt and one of the pens with which he signed that legislation. The exhibit has special security requirements.

#### ORAL HISTORY

TVA's 50th Anniversary Oral History Project is identifying and interviewing knowledgeable people about the formulation, implementation, and ramifications of legislative mandates and internal TVA policies and programs upon the agency and the natural and human environment. Specifically, this project concentrates on collecting information about the agency's power program, water control (including navigation and floodplain management), environmental policies and programs (including fertilizer research and development), community and regional development, and agency reorganizations. Former TVA employees and power distributors, as well as other people who were directly affected by the agency's programs, are being interviewed.

Fifty to seventy-five interviews are planned. The agency will release the transcripts and tapes for research through the TVA Technical Library in Knoxville as they are completed.

The Chattanooga-Hamilton County Bicentennial Library launched its oral history project in early 1982 to record the social, cultural, political, and educational history of the Chattanooga area. Included in the project is a special segment pertaining to Fort Oglethorpe, Georgia, a military installation during both world wars. To date, twenty-two interviews have been transcribed, edited, indexed, and cataloged. The tapes and transcripts are available to the public in the Local History section.

#### **COMPUTERS**
